An amendment to PEC's Engineering Education Regulations had been set aside by a Single Bench of the Lahore High Court. I successfully represented Appellant PEC in its Intra-Court Appeal and got the judgment reversed.

(iii) Reliance IT Solutions (Pvt.) Limited v. Federation (Reported as 2021 MLD 1846)

Represented a Swiss technology company in this case which concerned a challenge to a public procurement being carried out by the Federal Board of Revenue regarding Tracker Tracing System for Tobacco sector.

(iv) CM Pak Limited versus Pakistan Telecommunications Authority Others (Reported as PLD 2018 Isl.

The Petitioners whom I represented challenged the practice of network shutdowns on the basis of Section 54 of the Pakistan Telecommunications (Reorganization) Act, 1996. The Islamabad High Court accepted our petition and the Court's judgment in this case has been widely reported in the media and is considered a seminal precedent in Pakistan's free speech jurisprudence and telecom law. The case has also been profiled by the Columbia University's relevant website.

#### (v) Mahera Sajid versus SHO, PS Shalimar (Reported as 2018 CLC 1858 Islamabad)

One of the most seminal cases on the issue of missing persons and enforced disappearances. Successfully represented the wife of one such missing person. The Hon'ble Islamabad High Court accepted the petition and held that until the *detenn* was found and returned to the family, the State shall bear the expenses of the dependents.

#### (vi) Shahid Tufail Khan versus ZTBL (Reported as 2021 PLC(CS) 1130 Islamabad)

Successfully represented an employee of ZTBL affected as a result of the policy of promotion adopted by the Bank. The Hon'ble Islamabad High Court accepted the petition, agreeing with the stance that the Bank had failed to comply with the judgment of the August Supreme Court in the same matter, and thus, directed the Respondents to comply with the judgment and constitute a valid Board.

(vii) Saeed Abdi Mahmud versus NADRA (Reported as 2018 CLC 1588 Islamabad)

Successfully represented the Petitioner in a seminal case related to citizenship. The Hon'ble Islamabad High Court accepted the petition and directed the Petitioner to approach the Respondents for citizenship, which would be duly processed by the same.
